## **FIRST AMENDMENT TO INTRAMUNICIPAL AGREEMENT**

This First Amendment to Intramunicipal Agreement (the “First Amendment”) is made this \_\_\_ day of \_\_\_\_\_, 2022 (the “Effective Date”) by and between the Town of Nantucket (the “Town”), acting through its Select Board, the Nantucket Airport Commission (the “Commission”), and the Wannacomet Water Company (the “Company”), acting through the Nantucket Water Commission (collectively, the “Parties”).

WHEREAS, the Parties entered into an Intramunicipal Agreement dated November 10, 2020 (the “Agreement”) to permit the parties to connect certain residences to municipal water where those residences’ water supply was impacted by a historic release of per- and poly-flouroalkyl substances (“PFAS”) on and adjacent to the Airport Property; and

WHEREAS, the Parties now wish to amend their Agreement to permit the Commission to pave Skyline Drive, an area of the Town in which the Work under the Agreement is intended to occur, at the Town’s sole cost and expense;

NOW, THEREFORE, in consideration of the mutual covenants contained herein, and for other good and valuable consideration, the mutual receipt and legal sufficiency of which are hereby acknowledged, the Parties agree as follows:

1. Scope of Work. Effective upon the date of this Amendment, the Scope of Work described in Section 1.2 of the Agreement shall be amended to add a new subsection after 1.2, as follows:
  - 1.2.1. In addition to the Scope of Work described in Exhibit A, the Commission shall pave the portion of Skyline Drive served by the water main installation taking place under the Agreement in accordance with Town specifications, and at the Town’s expense. The Commission shall not be responsible for any future maintenance or replacement of the paved surface, stormwater infrastructure, or any other appurtenances associated with Skyline Drive.
2. Payment and Financing. Effective upon the date of this Amendment, Section 2 of the Agreement, Payment and Financing, shall be amended to add the following:

Notwithstanding the foregoing, the Town shall pay the Commission for the cost to pave Skyline Drive, as described in Section 1.2.1 of this Agreement. The Commission shall have no obligation conduct said paving until the Town has certified that funds available to cover the cost of such paving is available to pay for the reimbursement of the Commission’s costs in connection therewith.
3. Full Force and Effect. Except as modified by this Amendment, the Agreement and all terms and conditions thereof shall remain in full force and effect and are hereby in all respects ratified and confirmed. All capitalized terms used herein shall have the same meaning as in the Agreement.
